### Reservation and Payment Schedule

Early reservation is essential as availability is limited. Reservations are confirmed only upon receipt of a SIGNED application and a \$500.00 non-refundable, non-transferable deposit. We accept Visa / MasterCard / Discover and personal checks made out to **Linden Center, LLC**. Remaining balance of full payment price is due 61 days before departure date and non-refundable within 60 days of tour departure date. Single room supplement reservation is an additional \$500 after the stated program price. Price excluding international airfare is \$900 less the total program price.

### Medical Conditions

If you or any member of your party suffers from any physical challenge or medical condition, you must check with your doctor about the advisability of traveling and you must make this known to us before you book. We will make reasonable attempts to accommodate the special needs of our tour participants, but the Linden Center is not responsible for denial of services by carriers, hotels, restaurants or other independent suppliers. We are located at 7000 feet high and may travel up to elevations of 11,000 feet. **Trips to areas of higher altitude, for example, 7,000 to 11,000 feet, will be at the risk of the travelers who must confirm with their doctor if there are individual personal risks.**
